**Dear Moolah Club Member,**

Over the decades of my tenure within the judiciary as a prosecutor and magistrate, I have gained deep insight into the challenging circumstances faced by lawful firearm owners due to our expensive and slow-moving judicial system.

Legal complexities have escalated for firearm owners because of additional criminal offenses introduced by new legislation. Often, these individuals are represented by attorneys who may not fully grasp these complexities, putting them at a significant disadvantage. Our aim is to provide firearm owners with access to the expert legal representation they need, precisely when they need it, and at an affordable cost. In partnership with Wildman, we are offering Moolah members a complimentary legal advice benefit included in the Firearms Guardian policy. Our observations reveal that many defendants could have mitigated their legal troubles significantly had they known what to say and what not to say or do in the aftermath of a shooting incident.

It is a great honour to offer this essential service to lawful firearm owners, who are the pillars of safety in our society.
